The following measures must be taken to avoid significant impacts on listed threatened species and communities (sections 18 & 18A)

Measures to protect the Grey Box (*Eucalyptus microcarpa*) Grassy Woodlands and Derived Native Grasslands of South-eastern Australia ecological community; Swift Parrot (*Lathamus discolor*); Regent Honeyeater (*Anthochaera phrygia*) and Painted Honeyeater (*Grantiella picta*).

- 1. **Tree protection zones** must be established for all **eucalyptus trees** and native vegetation **patches** to be retained as shown in Appendix 1.
- 2. **Tree protection zones** established for **Grey Box Woodlands** must be not less than 15 metres.

Definitions:

Construction means all physical works associated with the proposed action, including digging and drainage and any preparatory works required to be undertaken, including temporary buildings but excluding the installation of temporary fences and signage.

Development footprint means the area identified as 'Impact area' as shown at Appendix 1

Eucalyptus trees means trees of the eucalyptus genus occurring within the **development footprint** including White Box (*Eucalyptus albens*), River Red Gum (*Eucalyptus camaldulensis*), Yellow Gum (*Eucalyptus leucoxylon*), Yellow Box (*Eucalyptus melliodora*) and Grey Box (*Eucalyptus microcarpa*).

Grey Box Woodlands means the EPBC Act listed ecological community Grey Box (*Eucalyptus microcarpa*) Grassy Woodlands and Derived Native Grasslands of South-eastern Australia.

Impact and Impacted means a loss or reduction in extent or quality.

Patch and Patches means a discrete and continuous area of the ecological community but including small-scale disturbances such as tracks or breaks.

Tree protection zone means an area established in accordance with the Australian Standard AS 4970-2009 – Protection of trees on development sites prior to commencement of **construction** and maintained during **construction** and where **construction** activities, vehicles, machinery or equipment are not allowed.
