### Community Reference Group Guidelines

ACEN Australia is continuing its support of the New England region, investing \$150,000 through its New England Solar grants in 2024.

To help administer those grants, we're inviting expressions of interest to become members of the Community Reference Group (CRG) for our New England Social Investment Program (SIP).

As ACEN Australia prepares to begin construction of Stage 2 of New England Solar, our community funding contributions also enter a new phase, with a refreshed Social Investment Program supported by the CRG.

The New England SIP provides funding for initiatives that contribute to building thriving and resilient communities and economies. The CRG is valuable in providing local insight to how SIP grants, sponsorships and donations can make the most effective contributions to the Uralla district and surrounds.

The updated CRG will comprise five community members and will be facilitated by ACEN Australia's Communications and Community Engagement Specialist - New England. It will consider applications for two rounds of funding in 2024.

Expressions of interest to be a member of the CRG in 2024 are open until 16 February.

## Emphasis on Diversity

The CRG will benefit from a diverse range of community knowledge and experiences. Panel members should represent the community as broadly as possible, from various parts of the Uralla district and surrounds, and including a variety of ages, cultural and business backgrounds and interests.

Young members of the community, aged 15 and over, are particularly encouraged to apply.

Everyone living or working within the Uralla Shire Council region is eligible to apply to join the Community Reference Group, as well as Kelly's Plains and Dangarsleigh residents within 5km of New England Solar Farm. Applications to join are also encouraged from members of the Anaiwan community.

## Fostering Strong Connections with Community

Since its inception in 2020, the New England Solar SIP has been a key tool in fostering the partnership between New England Solar and the Uralla community.

The New England Solar SIP has contributed \$200,000 to groups in Uralla Shire, including Kingstown Pony Club (pictured below).





## Roles and responsibilities for CRG members

The panel will consider two rounds of funding in 2024. The first will open in February and the second in July.

CRG members will be required to meet at least twice for each of the two rounds for 2024 (minimum four meetings per year), with additional meetings as members deem necessary.

Members can participate in these meetings either in person or virtually via video conference. Attendance in person is preferred where possible. Panel members will also help spread the word about the Social Investment Program and encourage local groups and individuals to apply.

ACEN Australia will reimburse panel members for reasonable and agreed expenses in carrying out their roles with the CRG.

Each member will have the option to continue for a second year in 2025.

## 2024 CRG & grants schedule

**16 February:** CRG expressions of interest close  
**29 February:** CRG members confirmed

**1 February:** Applications open for SIP grants Round 1  
**29 March:** Applications close  
**May:** SIP Round 1 grant recipients announced

**July:** Applications open for SIP grants Round 2  
**August:** Applications close  
**October:** SIP Round 2 grant recipients announced



The Community Reference Group is a fundamental part of New England Solar's Social Investment Program, adding transparency and local insight to the allocation of grants, sponsorships and donations.

Panel members will make recommendations and act in a manner to further interests of the broader community and the New England Solar Farm and consistent with ACEN Australia's values and standing as a good corporate citizen within the community.

Members will be required to disclose any perceived or potential conflicts of interest in their roles with the CRG and manage conflicts in accordance with a conflict of interest policy. They will act as representatives of the whole community and not as representatives of any special interest groups or organisations.
